
FILLED FITTING PRODUCT - 20 YEAR LIMITED WARRANTY

HRM Holdings, LLC, dba **Blueline Technologies**, warrants to the original owner/user that Blueline filled fitting products that are correctly installed, filled with Blueline approved material, and by a trained and certified installer in accordance with official Blueline Technologies installation instructions will not leak under normal exposure to fuels, water, and environmental conditions present in areas for which the Product is designed and intended to be used for a period of twenty (20) years from the date of installation. Blueline Technologies will replace any Product that deteriorates to the point of leakage during such twenty (20) year period. Warranty replacement Products will continue to be covered by the original Product's warranty for the period corresponding to the remaining warranty period of the original Product. "Leak" for the purpose of this warranty is defined by a fitting's failure to keep water or fuel in or out of a containment sump. If a leak results from this type of deterioration it will be considered a Product failure and will constitute a legitimate warranty claim. Swelling or discoloration that does not materially detract from Product's performance does not constitute deterioration of the Product that is covered by this warranty.

Limitations and Exclusions

1. Blueline Technologies' obligations under this warranty and the sole remedy for its breach are limited to replacement of any Product that is covered by this warranty, or a refund of the original purchase price of the fitting installed, excluding fillers or bonders. Costs of removal of the defective Product and installation of the replacement Product are specifically not covered by this warranty.
2. This warranty is not valid unless the original installation of the Product was performed by a certified and trained installer using official Blueline Technologies installation instructions, using approved filling and bonders.
3. Blueline Technologies will have no obligations under this warranty with respect to Products that have been modified or damaged through misuse, abuse, accident, neglect or mishandling by the installer, purchaser or purchaser's customer.
4. Damage to Products caused by structural failure of the underground fuel supply and containment system in which the Product is included, or fire, earthquake, other natural or man-made disaster, or other *force majeure* events are not covered by this warranty.
5. This twenty (20) year warranty is exclusive to filled fittings that begin with the letters "EXT". All other parts carry the normal three (3) year warranty.
6. This warranty excludes use with double walled sumps
7. This warranty excludes labor, and is for the replacement of the original product with a similar appropriate new product

Notification of Claim

The original owner/user of the Product for which a claim under this warranty (a "Claim") is being made must notify Blueline Technologies in writing of any Claim within fourteen (14) days of becoming aware of the Product deterioration or failure. A notice of Claim must include the following information: site name and address, pictures and details of the failing Product, the name and address of the installing contractor's company, the name of the individual trained installer who carried out the work, and the date of installation of the Product. The owner/user will also provide such other information as requested by Blueline Technologies. Blueline Technologies reserves the right to perform onsite inspections with respect to all Claims. If Blueline Technologies determines that the Claim is not covered by this warranty, the owner/user will reimburse Blueline Technologies for its costs and expenses incurred in connection with the onsite inspection. Failure to provide the information required herein in connection with a Claim or failure to permit Blueline Technologies to conduct an onsite inspection will constitute a waiver of all rights under this warranty. Blueline Technologies' determination with respect to the applicability of this warranty with respect to any Claim will be final.

THIS WARRANTY IS THE SOLE AND EXCLUSIVE WARRANTY FOR BLUELINE TECHNOLOGIES PRODUCTS, AND IS IN LIEU OF ALL OTHER EXPRESS AND IMPLIED WARRANTIES. HRM HOLDINGS, LLC, DBA BLUELINE TECHNOLOGIES, SPECIFICALLY DISCLAIMS ALL OTHER EXPRESS AND IMPLIED WARRANTIES, INCLUDING, BUT NOT LIMITED TO, ALL IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. No person is authorized to bind HRM Holdings, LLC, dba Blueline Technologies, to any other warranty, obligation or liability for any Product. Installation and use of a Product for which this warranty is issued shall constitute acceptance of the terms hereof.

Unintended Use of Products

Products are intended only for installation by Blueline Technologies' certified and trained installers, and only for the intended uses as described in the corresponding current Blueline Technologies training manual. If using a Product for any use or application not described in the Blueline Technologies training manual, the owner/user shall assume all risk and liability in connection with such other use or application.
